REPORT FROM MAYOR BURCH – Spoke with Cowan Engineering, will advertise for bids August 6; August 27, open bids (can award at this time if special meeting held); September 14, pre-construction meeting and begin work; October 14, complete construction, if given 30 days. Request for permit to construct has been submitted DEQ.

REPORT FROM RICK SCHLEGEL ON CINCINNATI SEWER LINE – The line has been surveyed and camera inspected. The line has separated where the 6" line meets the 8" line, and has formed a large cavity. Mr. Schlegel recommends repairing this by pipe bursting with an 8" line from manhole to manhole.

WATER LOSS – Mr. Eaton is concerned that we are losing revenue from water loss. There was discussion that the City of Tulsa water meter may not be working properly and that there are a lot of old residential water meters that need to be changed out. Talked about installing another 10" meter on our side of the Tulsa meter, to check usage. Motion by Burch and second by Wensman to have a special meeting work session on August 22 at 10 a.m. to discuss the water loss.
