DISCUSS GRANT OPPORTUNITIES – Megan Douglas with INCOG gave the board a summary of upcoming grant opportunities. She advised the board that there will be guaranteed funding from an Urban County CDBG grant, in the approximate amount of \$105,000.00, in the summer of 2020. An income survey of the entire town will have to be completed and application submitted in Spring 2020. There is also a competitive INCOG REAP grant up to \$60,000.00 for transportation projects and up to \$40,000.00 for community development projects with an application deadline of October 4, 2019. Mayor Burch and the board of trustees expressed their gratitude to Megan for all her help in applying for these grants.

Mayor Burch informed the board that she spoke with ORWA and they can provide smoke testing of our sewer lines free of charge.

RETAIN COWAN GROUP – Motion by Morton and second by Wensman to retain Cowan Group Engineering LLC to prepare the required preliminary engineering report to submit with the Rural Economic Action Plan grant application documents for the Atoka Water Line Replacement Project, at a cost not to exceed \$3,000.00.
