APPROVE MINUTES – Motion by Morton and second by Wensman to approve the October 8, 2020 regular meeting minutes. Yes: Burch, Butler, Wensman, Beck, Eaton, Morton. No: None. Motion carried.

DELINQUENT ACCOUNTS - Reviewed.

GAS AND WATER LOSS - Reviewed.

LEASE PAYMENT TO THE TOWN – The lease payment to the Town for the months of July and August were not paid. UPDATE ON PROJECTS – Atoka Project: This will be covered in agenda item #11. Cincinnati Project: The environmental study is complete and should be approved in December. Solicitation of bids will be in January, 2021. DEQ has approved the sewer line repair project.

ATOKA WATER LINE REPLACEMENT PROJECT – The sealed bids for the Atoka Water Line Replacement Project were opened November 10, 2020 at 10:00 a.m. The bid consisted of ten responsive bidders. The apparent low bidder at bid opening is Bates Instrumentation LLC, with a base bid amount of \$67,861.21. Motion by Burch and second by Beck that the bid for the Atoka Water Line Replacement Project be awarded to Bates Instrumentation LLC, the lowest, responsible bidder, in the amount of \$67,861.21, subject to the execution of a contract and furnishing of all required bonds and insurance. HIGH WATER USAGE AT 210 N. FRANKFORT – Mr. Wilstead feels that the high water usage problem started in January 2020 when a new water meter was installed. He feels that at that time, his line was cracked at the connection and has been slowly leaking since. He would like an adjustment on his bill back to that time. The leak was repaired and a new meter was installed in October 2020. Motion by Morton and second by Burch to wait until the end of February 2021 to determine the average usage on the new water meter which was installed October 2020. EXECUTIVE SESSION ACTION – Mayor Burch read the following statement before a motion was made:

"Let me just say that this has been the most unique year. Starting March 19, 2020, when we had to issue our first Resolution literally shutting down the Town, to news this week of rising numbers in test results and hospitalizations.

Through all of this you have seen this group of employees come to work each day, knowing that it could jeopardize their health and that of their families.

Shutting access to our building did not mean we quit working. Kanda and Renee' came in, processed utility payments, took information to give to Ron. Our SUSA crew, Ron, Micah, Michael and Bill monitored our needs as a Town to make sure that each home had water, sewer and gas.

The Fire and Police Department continued their commitment to keeping our town safe by risking themselves every time they went on a run, not knowing whether they were running into an active COVID situation.

As a Town board, we have been neglect in reminding you of how valuable each and every one of you are to our Town and tonight we wish to formally recognize you, and on record officially thank you for your dedication and service to our community. Thank you!"
